- 1. Data Model v5.3 is a standard release which participants can upgrade from DM5.2 or DM5.3_PreRelease.
- 2. Participants currently on the Data Model v5.2 having active bidding system running, applying DM5.3_PreRelease will ensure their bidding operational dependencies are covered. Please refer to the release notes from the v5.3 PreRelease release folder.
- 3. As a part of this upgrade release the following tables are updated with primary key modifications, please refer to the DM5.3_PreRelease on the bidding changes.

- 4. PD7- PreDispatch 7 Day table updates- As a part of this upgrade release, we are also adding below PD7 tables to the Data Model. The existing tables, PK, constraints for the below tables will be renamed before applying the

 - PD7DAY CONSTRAINTSOLUTION
 - PD7DAY INTERCONNECTORSOLUTION
 - PD7DAY MARKET SUMMARY
 - PD7DAY PRICESOLUTION
- 5. AEMO is aware that there are a number of participants who have manually created tables to support ingestion of PD7DAY data into their data model database.
- 6. For those participants who have PD7DAY tables already defined in their database, these tables will be renamed, and new tables created to ensure alignment with the AEMO Participant Data Model design.

- 7. If participants have defined roles for accessing these tables, then these role definitions will need to be applied to newly created tables.
- 8. Participants will need to migrate the data from self-defined structures into these newly defined tables. We wouldn't be able to provide back population scripts as we won't have visibility on the participant defined structure.
